## Minutes of JVVAOA Adjourned Annual General Body meeting held at Akash Ganga (Community Health Centre) on 25th Sep 2011

The house assembled at 09.30 hrs on 25.09.2011 along with the following Board of Managers present

The required quorum of 71 members was not present and therefore the house was adjourned till 10.00hrs. The total members present were 98 including 23 proxies at this time and the house was called to order. The President welcomed the members and proxies and entrusted the Joint –Secretary to present report to the General Body.

- 1. Minutes of AGM 2010 were considered read out, since already circulated to the members and ratified. The minutes were proposed for ratification by Wg.Cdr. Jagan Mohan and ratified by General body.
- 2. Approval of Audit Report: Sri. S.C. Bose of M/s S.C. Bose & Company has presented the clarifications sought by the members during the earlier AGM held on 17 July'2011.
- Sri. G. Narayana Swamy emphasized the need to streamlining of balance sheet, keeping in view the activities of the Jal Vayu Vihar Apartment Owners Association and maintaining necessary accounting standards. He volunteered to be a member of the committee to suggest improvements in the accounting procedures presently followed. Other members of the committee will be Commodore V. Kumar and Sri.T.Venkateshwara Rao.

The Balance Sheet for the FY 2010-2011 along with audit report presented to the members was proposed for approval of the General Body by Wg.Cdr.K.P. Rao, seconded by Dr. N. Chalamaiah and approved by the General Body.

a) The additional Audit fee of Rs. 5,000/- payable to M/s S.C.Bose & Company for additional work done during July'2011 to Sep'2011 as well as the Annual Audit fee of Rs. 25,000/- for 2011-2012 was unanimously approved by the members.

- b) Cdr. Naresh requested for more clarity in presentation of Audit report in future and appreciated the services of M/s S.C. Bose & Company.
- 3. New Complex Construction Account: Members have gone through accounts presented towards the construction of New Complex up to March 2011 and wanted to know the details thereafter. After deliberations it was decided that M/s S.C. Bose & Company will present the report of April'11 to Sep'2011 during Oct'11 along with audit report of half year ending Sep'2011.
- 4. Election of Board of Managers:- President proposed election of members for BOM with 6 from type VI, 3 from type V&VH and 2 from type II, III& III H as per the Bye-Laws. Sri. URK Prasad ( DU No.240) and Sri. K.V. Satyanarayana ( DU No. 4) amongst others stated that the Bye-Laws are not valid and are not legally tenable. Members from type II, III and V have stated that lot of damage has been done to them with the unequal representation on the Board of Managers and decisions imposed by majority type VI members. The demand was for equal representation on BOM of three members each from type VI, type V & VH, type II, III & III H. The aggrieved members further stated that if the above is not accepted, then the Association might have to be bifurcated.

Some members suggested that only members who can spare their time voluntarily for the Association and who can continue to be available for the full year only must come forward to be on the BOM.

After deliberations the house came to the conclusion and decided that an ad hoc BOM with two members each from type VI, type V & VH and type II,III, III H be elected and entrusted with the primary task of formulating the legitimate Bye-Laws and also to carry out the day to day business of the Association till the next committee is elected.

All members have agreed to this proposal unanimously . The following members were elected
