Meeting Started as scheduled at 10 AM. Vice President acting as President chaired the meeting, as there was no quorum, President adjourned the meeting and called to reassemble after 30 minutes to carry forward the business as per the norms. Members gathered again at 10:30 AM and the Meeting started.

ITEM NO 1

Annual Accounts:

President presented the accounts for the Year Ending 31st March 96. Treatment of depreciation was discussed. It was suggested that we can get the Asset Value of common utilities (viz., Water tank, Transformers, boundary walls etc.), transferred in to our books, claim a higher depreciation in the books and thereby reduce the tax liability, It was agreed to get the book values of these items from AFNHB and include them after consulting with the auditors.

Members questioned about the available reserves and the liquidity:

Auditor clarified that, the reserve position of the association is very much in order but the liquidity is not immediate. This is due to reserves being parked in long term securities of Unit Trust and Bank Fixed Deposits. However in emergencies these can be withdrawn prematurely with 40-50 day notice in case of UTI.

Accounts were taken as read, proposed by F/L Shankar and seconded by Sri Narayana Swami.

ITEM NO 2

Appointment of Auditors:

Sri P Viswanadh and associates were proposed again as auditors and accepted. Their request to increase the audit fee from Rs 2000 to 2500 was approved by members.

ITEM NO 3

Increase in the Maintenance charges

As proposed in the 94-95 AGM, it was agreed to approach the Hyderabad water works to increase the contracted water intake to 2,00,000 litres per day from 1,50,000 litre per day so that in the case of excess water demand, penal rates are avoided. This action was taken up and Hyderabad water works agreed to supply the above water subject to revising the contract with an additional deposit of Rs. 72,000. Also Andhre Pradesh Electricity Board added a new tariff in the name of Additional Consumption Deposit (ACD) to be paid annually.

To meet these two additional expenditures which will benefit the residents (owners/tenants), it was proposed to increase the maintenance of type VI and V by Rs. 50/per month, Rs.40/- for type III and II and Rs. 10/- for those Extra rooms with independent water connections.

1. Wastage of water:

1. Bye-Laws:

The draft Bye-Laws, excepting those concerning Membership of the Association and proxics, circulated vide notice dt 20 March 96 were by and large acceptable to the members with minor amendments.

It was proposed by Gp Capt TCS Rao that after a wider interaction between members, a consensus may be arrived at in respect of the above points of contention in the draft bye-laws and the same may be put up for approval in the next AGM.
