1. Approval for Motor Repair at Tank No. 2

Agenda: Approval for motor repair at Tank No. 2, with an estimated cost of around ₹25,000.

Decision: The total cost for the repair, including material and transport charges for fitting the motor at Tank No. 2, is ₹25,000 and has been approved.

2. Dump Yard Wall Construction

Agenda: Initiation of work for dump yard wall construction and review of quotation status, as approved in the AGM.

Decision: Construction of the dump yard wall has been approved at a cost of ₹4,70,000.

3. Water Line Repair/Upgradation

Agenda: Review of quotation status for water line repairs/upgradation, as approved in the AGM.

Decision: It was discussed to lay a new water line from the bus stand to DU No. 101. The AGM-approved budget of ₹3,00,000 will be utilized, and the work will be initiated..

5. Survey of Open Lands



Agenda: As per the request from Naidu Garu and Type V owners, a detailed survey of all open lands to identify and reclaim areas mistakenly handed over to GHMC. Approval sought for surveyor cost (₹10,000-₹15,000).

Decision: An amount of ₹20,000 has been sanctioned for appointing a surveyor to conduct a survey of the entire colony.

Agenda: Submission of resignation with immediate effect.


Decision: The Board discussed and accepted the resignation of SFO Laxmi Rajam Garu with immediate effect.






