


A BOM meeting was held at 7.15 pm in JVV Office on 08 Sep 2024 which lasted for 1 hr 30 minutes.



 - Volunteers to be invited from the colony to go through the Parking Committee recommendations and suggest changes if any. It will be a single


committee comprising of parking areas covering the entire colony including Aakash Ganga as per AGM minutes.


